

Pursuant to section 183(e) of the Clean Air Act (42 U.S.C. Section 7511b) and 40 CFR Part 59, and subject to the terms and conditions prescribed in those provisions, this certificate of conformity is hereby issued with respect to portable fuel containers which have been tested and found to conform to the applicable requirements of 40 CFR Part 59 and which represent the portable fuel containers listed above by Emission Family, more fully described in the manufacturer/importer's application for certification. Vehicles covered by this certificate have demonstrated compliance with the applicable emission standards, as more fully described in the manufacturer/importer's application. This certificate covers the above portable fuel containers, which are designed to meet the applicable emission standards specified in 40 CFR Part 59 as specified in the manufacturer/importer's application for the production period listed above.

It is a term of this certificate that the manufacturer shall consent to all inspections in 40 CFR 59.698 and authorized in a warrant or court order. It is also a term of this certificate that this certificate may be revoked, suspended, or rendered void for failing to comply with the requirements of such a warrant or court order, or for other reasons specified in the provisions of 40 CFR part 59, including the provisions of 40 CFR 59.602 and 40 CFR 59.629.

This certificate covers only those vehicles which conform, in all material respects, to the design specifications that applied to those vehicles described in the documentation required by 40 CFR Part 59 and are produced during the production period stated on the certificate as defined in 40 CFR Part 59. The manufacturer/importer shall obtain the approval of the California Air Resources Board (in the form of an executive order issued by the California Air Resources Board) prior to introducing any portable fuel container covered by this certificate into commerce (1) in the State of California, or (2) in a State that, under the authority of Section 177 of the Clean Air Act, has adopted and placed into effect the California standards to which this emission family has been certified. This Certificate does not cover portable fuel containers sold, offered for sale, introduced, or delivered for introduction into commerce in the U.S. prior to the effective date of the certificate.
